ANZBAI Mumbai started as an informal opportunity for Australians and New Zealanders to meet socially and share and leverage off one another's experiences. ANZBAI has evolved into a strong networking forum, with well-attended social get-togethers and business events.

Please read this document carefully before filling in the detail. Memberships are broken down in to different categories as determined by the Board of Directors of ANZBAI (Mumbai) Business Forum. Our memberships are aligned to the Indian financial year period; being April to March annually.

ANZBAI Mumbai is a registered charitable organization who provide a variety of social and business events for our members during the year, with money raised through events being distributed to registered charities within India on a regular basis, as determined by the Board of Directors.

Membership of ANZBAI Mumbai requires a connection with either or both Australia and New Zealand, by way of birth, citizenship, residency, temporary student status, or by way of doing business with either or both countries. The Board of Directors of ANZBAI Mumbai reserve the rights to decline membership to any persons or organisations who do not fill this criteria or who are not deemed as suitable members of this organization.

Membership Categories

Corporate: Any corporation, organisation, government agency, firm or businesses that are local branches or subsidiaries of Australasian organisations, or can demonstrate an enduring business relationship with Australia and/or New Zealand.

Individual: Any individual person holding Australia or New Zealand citizenship or permanent residency or can demonstrate an enduring relationship with Australian or New Zealand. Alumni of Australian and New Zealand higher education institutions can also apply. Any Individual who can show they work for an India subsidiary of an Australian/New Zealand company whereby the said company objects to Corporate Membership of the individual, can, at the discretion of the Executive Committee of ANZBAI obtain Individual membership status.

Spouse/Partner: The Spouse or Partner of an Individual Member or a Nominee of a Corporate or NGO Member can apply for membership under this category.

NGO Worker/Student: Any individual Australian/New Zealander who is a NGO Worker/Full time Volunteer for a not-for-profit or a charitable organization, that can demonstrate an enduring relationship with Australia or New Zealand. Students who are currently enrolled with any Australian or New Zealand higher education institution and are currently based in India can also apply for membership under this category. This category of membership is subject to approval from the committee.

Annual Membership Fees

Corporate Members	Rs 23,000 p.a. (up to 3 representatives)
Corporate Additional	Rs 8,050 p.a.
Individual Member	Rs 6,900 p.a.
Spouse/Partner Member	Rs 3,450 p.a.
NGO Worker / Student	Rs 2,300 p.a.

A member joining the Association for the first time between April and September of any given year shall pay full Annual Membership Fees. A member joining the Association for the first time between October and March of any given year shall pay half of the stated Annual Membership Fees, being subject to Full Annual Fees the following and all subsequent years. All memberships expire on 31 March annually.

Voting & Transferability

Corporate Members shall have the right to nominate up to three individual persons employed by the Corporate Member as its representatives by notice in writing to the Executive Committee or at the time of application submission. Any of these representatives may be changed during a financial year, without any additional membership fee, once this has been confirmed in writing to ANZBAI. If a Corporate wishes to nominate more than three representatives, the additional representatives shall pay a reduced membership fee, as set by the Executive Committee.

Only the first member within the Corporate Membership category will have one vote.

Individual Membership is not transferable and is entitled to one vote
Spouse/Partner Membership is not transferable and is NOT entitled to vote

NGO Worker /Student is not transferable and is entitled to one vote.

Payment & Contact Information

The payment of fees is required to be made by bank transfer or local cheque drawn in favour of **ANZBAI (Mumbai) Business Forum** (payable at Mumbai) and sent along with this completed form and a clearly identified passport sized photograph of every member or nominated member.
